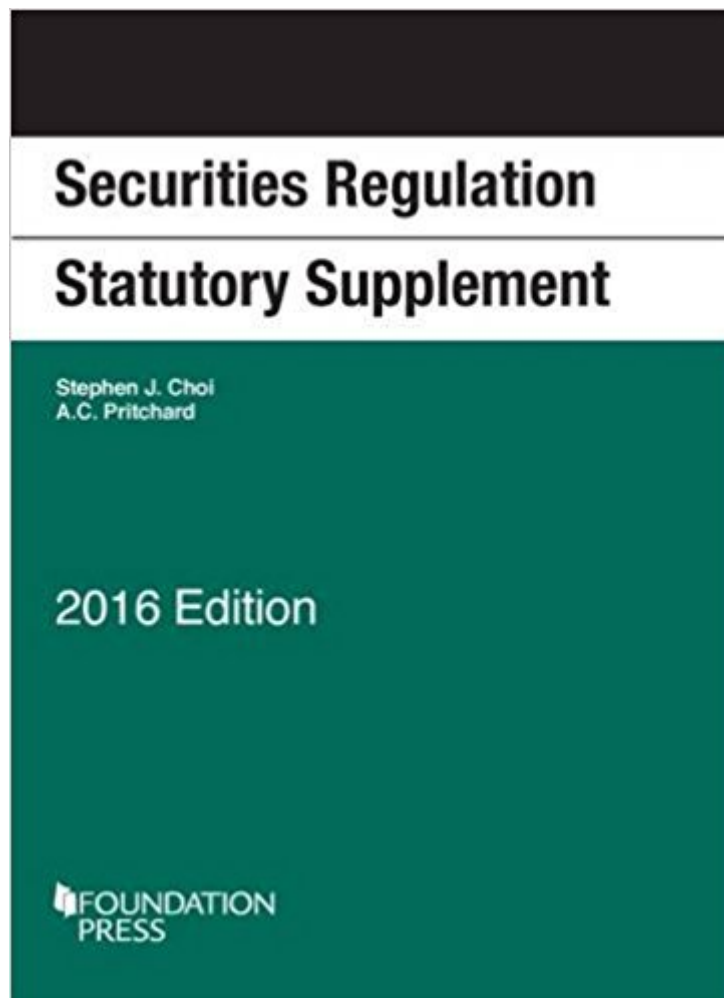

Needed some kind of editorial headings to make it easier to use for students trying to familiarize themselves with the statutes and regs. Its contents and headings were absolutely minimal. Also should offer a downloadable (PDF) pocket part to account for changes in the regulations that occur throughout the year. Significant portions of this supplement were outdated by the time I was using it in early 2017 (still the 2016 school year).

It may not have every single statute, but it does contain the most relevant. And compared to my class and professor's supplements, mine was the most accurate. For example, on the time frame allowed for road shows, the FAST ACT changed it from 20 to 15 days, this was done Dec 2016, and most supplements say that they are up to date with all laws ending Dec 31, 2016, but obviously not.
