

This book is awful. As a serious student who makes excellent grades and takes learning quite seriously, this book is insulting. As the previous reviewer stated, it is repetitive to the point that every chapter says the same thing. It's far too long and far too expensive. I am in a dual Social Work and Public Health program, and this is my fourth methods course that I have taken. I understand the value of a good textbook, and this is most certainly NOT a good text book. If you are a student required to have this book, buy the older edition and save yourself some money - the citations are not super current even in this sixth edition, you won't be missing much at all.

I have a lot of trouble with Research and Evaluation. The concepts are foreign to me and when they speak of the mathematical results they might as well be speaking a different language. However, this book is written in clear English with examples of each concept. So far I have a 100 in the class four weeks in and have had to use this book on the quizzes. I'm thankful to their plain language and examples but wish that eBook was available.
